2. It is your responsibility to report completed incentives to Tina. **Spring incentive deadline July 1st. Fall incentive deadline is November 17th 2023. No payments will be processed after December 18th, 2023.**

Final incentive payment amounts are dependent on available funds and may be pro-rated. Completed incentives will be reviewed on July 1st for Spring Incentives and November 17th for Fall Incentives. Field Day Hosts will be paid following the event they host and invoices will not be held until the spring or fall incentives are reviewed. If additional funds are available, spring incentives not reimbursed in the spring may be reimbursed later at the discretion of the council.
